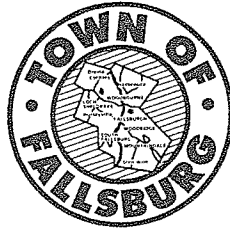


Supervisor Vegliante thanked everyone for attending and stated that the signs that did not sell will be showcased at another time / venue in the future.
