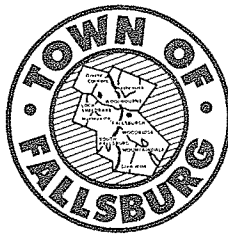

Councilman Seletsky: "Tentatively will be Sunday Memorial Day weekend, with the rain date Monday."


