

RESOLUTION # 172

**RESOLUTION REQUESTING SPEED ZONE STUDY**

**WHEREAS**, The Town Board has received complaints regarding traffic on Rosemond Road, which is located both in the Town of Fallsburg and Village of Woodridge; and

**WHEREAS**, Town residents who live on Rosemond Road stated to the Town Board that the current speed limit of 55 miles per hour is too high for the area;

**NOW THEREFORE BE IT RESOLVED**, That the Town Board of the Town of Fallsburg hereby requests that the County of Sullivan perform a speed zone study for Rosemond Road, between Lake House Road and Silver Lake Road, which is a 1.25 mile stretch, in order to reduce the speed from 55 miles per hour to a lower speed in order to allow residents to travel safely.


