INTRODUCTORY LOCAL LAW  
NOISE RESTRICTIONS**

PUBLIC NOTICE is hereby given that there has been introduced before the Town Board of the Town of Fallsburg, New York, on November 20, 2023, a local law, titled "Noise Restrictions," which local law would repeal the Town's existing Noise law and enact new provisions restricting noise and sound, including decibel level restrictions on noise levels in residential zoning districts and in non-residential zoning districts.

A complete copy of the Introductory Local Law is available for inspection at the Clerk's Office.
