Expiration DPW Capacity Services Application Permit Approval:

1. All capacity permits for Sewer and Water connection to any Town of Fallsburg Sewer or Water plants will expire after six (6) months from the date of the Town Engineer's signature above, unless ground has been broken on the project.
2. Definitions herein:
 - a. "Breaking Ground" shall mean when earth is moved, such as earth work, equipment installation, or other civil works, at the subject property and work on the foundation(s) has begun.
 - b. "Project" shall mean the total improvements included in the applicant's approved site plan from the Town of Fallsburg Planning Board for the SBL Number referenced in the DPW Capacity Services Application.
3. After the expiration of six (6) months, if ground has not been broken, as determined in the sound discretion of the Town Engineer and/or Code Enforcement Officer, based on the health, safety, and welfare of the community and other existing DPW Capacity Services Applications then submitted, the approval for Sewer and/or Water capacity will be deemed expired and the capacity held for the applicant may be allocated to other applicants then awaiting capacity.
4. If a written request for an extension is provided at least thirty (30) days prior to the expiration of the six (6) month period referenced above, the Town Engineer and/or Code enforcement Officer may provide a onetime extension of sixty (60) days from the end of the six (6) month time frame to break ground, as defined above.
